Voting in the August Election

On August 6, 2024, voters of the City of Odessa, Missouri, will be asked to establish a half-cent public safety sales tax that would improve funding for a new police facility for our community.



If approved, the tax would support the construction of a justice center including a much-needed storm shelter. This multipurpose facility would not only provide a secure environment for law enforcement operations and legal proceedings but would also serve as a designated safe space for residents during emergencies. By integrating advanced security measures and resilient infrastructure, this justice center would provide enduring protection and preparedness, enhancing community safety, and ensuring a lasting investment that would benefit generations to come. 2024 Puddle Jumper Days

Puddle Jumper Days will take place from Thursday, August 1, to Saturday, August 3. The carnival will begin set up on Monday, July 29, closing Dryden from Russell to Second Street (131 Hwy). Then starting around 11:00 am on Thursday, Dryden will be closed from Russell to Third Street, Second Street will be closed from Cobb Ave to the alleyway by Ralph O Jones Funeral Home, Mason will be closed from First Street to Third Street, and First Street will be closed from Orchard to the church alleyway. The majority of the streets, including Second Street, will be back open for traffic by Sunday morning, August 4.

Due to street closures, the only vehicle access to City Hall during Puddle Jumper Days will be the alleyway between Dryden and Mason off First Street.
