The Odessa Aquatic Center at Dyer Park opens on Memorial Day, Monday, May 27. The daily fee is \$5 for ages 3 and over. A season pass is \$90 for an individual. The family of four season pass is \$200 for four members, with \$30 for each additional person (family members must live in the same residence to qualify).

Pool hours are 1:00-6:00 pm Monday through Thursday, Saturday and Sunday, and 1:00-7:00 pm on Friday. Pool rental is available seven days a week for pool parties. 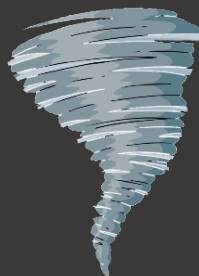
